 - Motion: Article 13. Bylaws Amendments, Section 1. Procedure, Subsection e.) Amend subsection e.) to read (*additions are underlined*): “Each Director must be notified of any editorial changes to these Bylaws by the Parliamentarian or the Bylaws Committee. Such editorial

changes shall be effective thirty days after mailing of such notice unless an objection is received in writing from three Directors by the Secretary. Any editorial changes made to these Bylaws shall be reported to the World Service Business Conference annually.
